Stud Service Agreement

Under the terms of this agreement, the undersigned parties agree to the following conditions in regard to the breeding of the golden retrievers identified below:

Policy For Approving The Bitch

The stud owner must approve the bitch before being accepted for breeding. The bitch must be in good health and condition, must be free from known hereditary defects, parasites, or infections and must be of good conformation and temperament, at the time of the breeding. If at any time, the stud owner determines that any of the above conditions have not been met, she retains the right to return the bitch to her owner, prior to breeding.

The bitch owner agrees that none of the puppies produced from this stud service shall be sold through a pet shop, agent or broker. The bitch owner agrees that none of the puppies produced from this breeding will be sold to persons or agents representing persons, residing outside the USA or Canada, without prior, specific written approval from the stud owner. The bitch owner agrees that said bitch should not be sold while she is in whelp without prior, specific written approval from the stud owner. The bitch owner agrees to sell puppies produced from this breeding with a contract forbidding the sale of the dog to a pet shop, agent or broker or outside the USA or Canada without prior, specific written approval from the stud owner. The bitch owner agrees that all puppies sold as pets will be sold on Limited Registration and/or with a spay/neuter contract. Upon request, the bitch owner agrees to furnish the stud dog Owner with the names, addresses, phone numbers, and email addresses (where applicable) of all people who purchase puppies from this breeding.

If the bitch owner fails to fulfill the conditions of this contract, the bitch owner will be responsible for reasonable attorney's fees, if action is taken by the Stud Owner on behalf of the bitch that was bred, and/or the puppies produced from this breeding. In addition, a monetary penalty of ten thousand (\$10,000) dollars will be assessed upon the Bitch Owner. If a puppy, produced from this breeding is sold to a person or agent of a person, residing outside the USA or Canada in violation of the Agreement, the bitch owner will be held responsible for all expenses incurred in returning said puppy/dog to the USA.

Bitch Owner's Responsibility

Prior to the stud service, the bitch owner will provide the stud owner with the following:

- A four-generation pedigree
- A copy of the Bitch's OFA report and/or PennHip report
- A current (within the last 12 months) eye report from a veterinary ophthalmologist
- A report from a Board-Certified Cardiologist or Board-Certified Internist, which shows the Bitch to be free of SAS, or other hereditary heart defects
- A negative brucellosis test, dated no more than thirty (30) days of the anticipated breeding date
- A negative vaginal culture or one that is considered normal by the bitch owner's vet.
