The stud service will be performed as soon as the bitch will allow, then subsequently every 36 to 48 hours, for as long as the bitch will "stand", unless otherwise instructed by the bitch owner. Only two (2) services are guaranteed per bitch. Artificial Insemination (AI) will be performed at the discretion of the stud owner and all vet costs for this procedure are to be paid by the bitch owner. Arrangements for AIs should be made with the stud dog owner's vet prior to the bitch being bred.

Every effort will be made to provide a safe environment for the bitch while she is in our care. Any instructions from the Bitch Owner will be carefully followed. In no way is the stud owner responsible for any injury to, or loss of the Bitch.

The stud owner will sign and return the AKC Litter Registration Application, or forward it directly to the AKC (whichever the bitch owner wishes), after the financial terms of this agreement have been met.

Guarantee

Three (3) live puppies constitute a litter. If less than 3 live puppies are whelped, a repeat service will be provided to the same bitch, provided that the stud is still in my possession and still being bred, within 18 months of the first breeding. The bitch owner may substitute another bitch (owned or co-owned by the bitch owner), provided that she meets the requirements of this agreement. No refund of the stud fee deposit can be guaranteed unless agreed to in advance. In the event that the deposit is refunded, there will be a breeding fee or \$250.00 charged against the deposit. If the breeding was an AI, using frozen semen, the breeding fee will be ½ of the original stud fee (\$500), unless agreed upon by the stud owner.

Financial Terms

A boarding fee of \$10/day will be paid to the stud owner if the bitch's visit exceeds seven (7) days. Transportation and veterinary expenses related to the bitch's breeding will be paid prior to the bitch being returned to her owner. Any unforeseen veterinary expenses relating to the breeding of the bitch will be paid along with the balance of the stud fee at the time the litter registration is signed by the stud dog owner. All expenses for the collection of fresh or chilled semen for the purpose of Al, and shipping costs of both chilled and frozen semen are the responsibility of the bitch owner. Payment arrangements should be made with my vet well in advance (30 days) of the first collection, preferably with a credit card number. In the event that my vet cannot accept a credit card number, the estimated costs for collection and shipping will be paid to the stud dog owner in advance of the first collection.

Additional terms and conditions:

- There will be an additional non-refundable \$25.00 per trip, charged for counter-to-counter shipping of chilled semen, to be paid with the balance of the stud fee.
- There will be an additional non-refundable \$100 for the use of frozen semen, to be paid with the stud fee deposit.

After reading the above terms and conditions, we find them mutually agreeable and acceptable. This contract must be signed by all Owners of the Bitch, as listed on her AKC registration.
